APCO's vision is a packaging value chain that collaborates to keep packaging materials out of landfill and retains the maximum value of the materials, energy and labour within the local economy.

Describe initiatives, processes or practices that you have implemented during your chosen reporting period that have improved packaging sustainability

We have been actively progressing towards replacing our plastic closures with paper based material with an aim to convert 100% of our closures to be manufactured by material that can be fully compostable. We have already converted approximately 30% of our closures to paper based material in the reporting year. Our 750ml and 2L PET bottles used as packaging food products have undergone light weighting. 12% reduction in weight for our 2L bottles and 20% reduction in weight of our 2L bottles. Closures used for these bottles have also been reduced in weight by 30%. That is an overall reduction of approximately 20% use of plastic across our range of packaging.

Describe any opportunities or constraints that affected performance within your chosen reporting period

Some design constraints prevent improvements as they potentially compromise the integrity and intended use of some of our range of packaging products which we are working through with expert advise.

As of now in the reporting year, we have converted at least 40% of our Closures to be made with Paper based material, thus eliminating the use of plastic.

As of April 2023, we have successfully reduced the weight of our 750ml and 2L PET bottles in 2023 by about an average of 20% without compromising the integrity of the packaging.

Closures used for these bottles have also been reduced in weight by 30%.

APCO Action Plan Commitments

Criteria 1:

Criteria 2:

Design & Procurement:

This criteria considers actions taken to ensure that sustainability principles are considered in the design or procurement of both new and existing packaging through use of the Sustainable Packaging Guidelines (SPGs).

- Review 100% of our packaging against the Sustainable Packaging Guidelines (or equivalent).
- Consider the following Sustainable Packaging Principles in our packaging reviews:
 - Design for recovery
 - Optimise material efficiency
 - Design to reduce product waste
 - Eliminate hazardous materials
 - Use recycled materials
 - Use of renewable materials
 - Design to minimise litter
 - Design for transport efficiency
 - Design for accessibility
 - Provide consumer information on environmental sustainability
- 94% of our packaging to be optimised for material efficiency.

Criteria 3:

Recycled Content:

This criteria considers actions taken to increase or optimise the amount of recycled material used by your organisation.

- Develop a policy or procedure to buy products and/or packaging made from recycled materials.
- Use recycled content in:
 - Our products
 - Primary packaging that we use to sell our products
 - Secondary packaging that we use to sell our products
 - Tertiary packaging that we use to sell our products
 - Other items which we purchase (e.g. office stationary and suppliers etc.)
- 79% of our packaging to be made using some level of recycled material
- Provide customers with the option to purchase packaging with the highest level of recycled content technically feasible.

Criteria 4:

Recoverability:





This criteria considers actions taken to improve the recovery of packaging at end-of-life and increase use of reusable packaging.

- 100% of our packaging to be designed to have all packaging components be recoverable at end-oflife.
- Improve the accuracy of our data regarding recoverability.
- Use PREP to assess the recyclability of our packaging through kerbside collection in Australia and/or New Zealand.
- Aim to have 20% of our compostable packaging certified to Australian standards.

Criteria 5:

Disposal Labelling:

This criteria considers the extent to which packaging has been labelled to help consumers determine what to do with packaging at end-of-life.

- Provide customers with information on the recoverability of our packaging to inform correct disposal labelling on-pack.
- 100% of our private label products to have on-pack labelling to inform correct disposal.

Criteria 6:

On-site Waste:

This criteria considers progress in increasing the amount of on-site solid waste being diverted from landfill.

- Have recycling programs for the following materials:
 - Paper/cardboard
 - Soft plastics
- Aim for 95% of our on-site waste to be diverted from landfill.

Criteria 7:

Problematic Materials:

This criteria considers the extent to which organisations are actively phasing out problematic and unnecessary single-use plastic packaging and preventing/reducing litter.

- Help reduce litter by:
 - Daily on site clean up
