Please tell us about any innovative packaging sustainability initiatives you have implemented during your chosen 12 month reporting period.

During our 12-month reporting period, we have focused on reducing packaging material by transitioning from DOY (stand-up pouch) to Pillow (hang cell) packaging. This change minimises waste by using less µm material while maintaining product protection and functionality. By optimising our packaging design, we are actively reducing our environmental impact and improving sustainability.

Please tell us of any constraints you may have had during your chosen 12 month reporting period that has impacted on your packaging sustainability initiatives and Covenant obligations.

A key constraint we faced during our 12-month reporting period has been retailer preferences, as many retailers continue to use DOY (stand-up pouch) packaging and do not yet utilise Pillow (hang cell) packaging. As a result, transitioning to the Pillow Bag format for our products would risk compromising product presentation and shelf appeal, making it challenging to align with our sustainability initiatives while meeting retailer requirements.
