APCO's vision is a packaging value chain that collaborates to keep packaging materials out of landfill and retains the maximum value of the materials, energy and labour within the local economy.

Please tell us about any innovative packaging sustainability initiatives you have implemented during your chosen 12 month reporting period.

In June 2023 (outside the reporting period), we relaunched our entire Personal Wash range with the objective of reducing our packaging waste to landfill (using the SPGs to maximise recyclability, maximise the use of post-consumer recycled material content, and reduce packaging generally). We now have the first 12 months worth of data for us to see whether consumers resonate with these innovative changes. While innovative product design falls outside this year's reporting period, our efforts (hopefully as innovative) over the last 12 months aimed to educate consumers on the aesthetic and material change in packaging, higher costs to order to continue selling our products and stay-on-shelf. Therefore, we conducted life-cycle-analysis in the reporting period, as well as other assessments (packaging impact assessments) which we will use results to continue education and inspiring our consumers on these new changes.

APCO Action Plan Commitments

For each of the Packaging Sustainability Framework criteria listed below, a description is provided along with the commitments made by the organisation in their APCO Action Plan.

Criteria 1:

Governance & Strategy:

This criteria considers actions to integrate packaging sustainability into business strategies.

- Develop a strategy that includes goals for packaging sustainability that addresses the Sustainable Packaging Guidelines (SPGs) or equivalent.
- Include a commitment to the 2025 National Packaging Targets and aim to integrate it within business processes.
- Communicate and promote packaging sustainability objectives and targets within your organisation and to external stakeholders (suppliers, final consumers, community groups etc.).

Criteria 2:

Design & Procurement:

This criteria considers actions taken to ensure that sustainability principles are considered in the design or procurement of both new and existing packaging through use of the Sustainable Packaging Guidelines (SPGs).

- Use the Sustainable Packaging Guidelines to review our packaging to identify opportunities for improvement.
- Record the outcomes of reviews or packaging using the Sustainable Packaging Guidelines so that any team member can refer back to them in future and for auditing purposes.





Conduct packaging reviews using the SPGs for 24% of our packaging.

Criteria 3:

Recycled Content:

This criteria considers actions taken to increase or optimise the amount of recycled material used by your organisation.

- Develop a policy or procedure to buy products and/or packaging made from recycled materials.
- Aim to use recycled materials in any packaging where this is feasible, including:
 - Primary packaging
 - Secondary packaging

Criteria 4:

Recoverability:

This criteria considers actions taken to improve the recovery of packaging at end-of-life and increase use of reusable packaging.

 Investigate whether all of our packaging is recyclable at end-of-life and identify any gaps and opportunities for greater reuse or recycling.

Criteria 5:

Disposal Labelling:

This criteria considers the extent to which packaging has been labelled to help consumers determine what to do with packaging at end-of-life.

 As packaging is updated or refreshed, add on-pack information for consumers on recyclability or correct disposal.

Criteria 6:

On-site Waste:

This criteria considers progress in increasing the amount of on-site solid waste being diverted from landfill.

No commitments have been made for this criteria this year.

Criteria 7:

Problematic Materials:

This criteria considers the extent to which organisations are actively phasing out problematic and unnecessary





single-use plastic packaging and preventing/reducing litter.

- Undertake the following to help reduce the impact of litter:
 - As we do not have any offices (we work fully remotely) clean-up on sites/business clean -up day is not applicable to us.

Further commitments:

These commitments look at additional actions the organisation may take to improve reporting.
