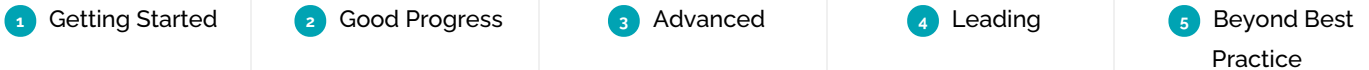
About APCO

- Achieved FSC Certification to support responsible sourcing of fibre-based packaging materials and certified paper and board packaging solutions.
- Developed a ready-to-recycle retort pouch structure aligned with APCO recyclability guidance.
- Undertook development of a fibre-based fresh produce punnet designed as an alternative to traditional PET produce packaging, while also improving transport efficiency through optimised pack configuration.
- Continued supporting customers with PREP assessments and Australasian Recycling Label (ARL) guidance to improve packaging recyclability outcomes and disposal information.

APCO Action Plan Commitments

For each of the Packaging Sustainability Framework criteria listed below, a description is provided along with the commitments made by the organisation in their APCO Action Plan.

Criterion 1:

Governance & Strategy:

This criteria considers actions to integrate packaging sustainability into business strategies.

- Develop a strategy that includes goals (objectives) and targets for packaging sustainability that addresses the Sustainable Packaging Guidelines (SPGs) or equivalent.
- Include a commitment to contribute to the achievement of the National Packaging Targets and aim to integrate it within our organisation processes.
- Communicate and promote packaging sustainability objectives and targets within your organisation and to external stakeholders (suppliers, final consumers, community groups etc.).

Criterion 2:

Design & Procurement:

This criteria considers actions taken to ensure that sustainability principles are considered in the design or procurement of both new and existing packaging through use of the Sustainable Packaging Guidelines (SPGs).

- Use the Sustainable Packaging Guidelines (SPGs) to review our packaging to identify opportunities for

improvement.

- Record the outcomes of packaging reviews using the SPGs so that a team member can refer back to them in future and for auditing purposes.
- Conduct packaging reviews using the SPGs for **80%** of our packaging.

Criterion 3:

Recycled Content:

This criteria considers actions taken to increase or optimise the amount of recycled material used by your organisation.

- Develop a policy or procedure to buy products and/or packaging made from recycled content.
- Aim to use recycled content in any packaging where this is feasible, including:
 - Primary packaging
 - Secondary packaging
 - Tertiary packaging

Criterion 4:

Recoverability:

This criteria considers actions taken to improve the recovery of packaging at end-of-life and increase use of reusable packaging.

- Investigate whether all of our packaging is recyclable at end-of-life and identify any gaps and opportunities for greater reuse or recycling.

Criterion 5:

Disposal Labelling:

This criteria considers the extent to which packaging has been labelled to help consumers determine what to do with packaging at end-of-life.

- As packaging is updated or refreshed, add on-pack information for consumers on recyclability or correct disposal.

Criterion 6:

On-site Waste:

This criteria considers progress in increasing the amount of on-site solid waste being diverted from landfill.

- Develop a system to collect and recycle used packaging generated at our facilities.

Criterion 7:

Problematic Materials:

This criteria considers the extent to which organisations are actively phasing out problematic and unnecessary single-use plastic packaging and preventing/reducing litter.

- Help reduce litter by:
 - Conducting regular clean ups on-site
 - Participating in a planned Business Clean Up Day
 - Looking for opportunities to redesign packaging to eliminate components that may have the propensity to become litter
 - During the reporting period, Allround Packaging undertook several activities to reduce the impact of litter and promote responsible waste management practices.
We conduct regular internal clean-ups within our office and operational areas to minimise unnecessary waste accumulation and ensure materials are appropriately sorted into established recycling streams.
Our team also participated in the annual Clean Up Australia Day business clean-up initiative, contributing to the removal of litter from the local environment and supporting broader community efforts to maintain clean public spaces.
In addition, Allround Packaging continues to work with customers to review packaging formats and reduce unnecessary or problematic materials where possible. During the reporting period, this included development of a fibre-based fresh produce punnet designed to replace traditional PET punnets, reducing reliance on plastic materials and improving overall packaging sustainability outcomes.
