Please tell us about any innovative packaging sustainability initiatives you have implemented during your chosen 12 month reporting period.

The following innovative packaging sustainability implemented in the 2024 include the

- a) RPAC has used reusable Bearhug Pallet Wrap replacing the Plastic Shrink Wrap. This has been shared with other Operating Companies in Danaher.
- b) One (1) manufacturer changed the temperature indicators to new material with limited amounts of plastic and delivery from UK instead of plastic.
- c) One (1) manufacturer has offered reverse logistics where applicable, ensuring reuse of packaging like Styrofoam pallets, thermal blankets, data loggers and embalso pallets

Please tell us of any constraints you may have had during your chosen 12 month reporting period that has impacted on your packaging sustainability initiatives and Covenant obligations.

Implementation of improvement opportunities and recoverability of packaging are sometimes not practical to do or too costly to implement.

However, we are currently working with our major manufacturers to work towards compliance with the requirements of APCO. As a result, one (1) of the manufacturers has started to update the Product Life Cycle Management (PLM) process to include sustainability initiatives to include the primary and secondary packaging.

APCO Action Plan Commitments

For each of the Packaging Sustainability Framework criteria listed below, a description is provided along with the commitments made by the organisation in their APCO Action Plan.

Criteria 1:

Governance & Strategy:

This criteria considers actions to integrate packaging sustainability into business strategies.

- Develop a strategy that includes goals for packaging sustainability that addresses the Sustainable Packaging Guidelines (SPGs) or equivalent.
- Communicate and promote packaging sustainability objectives and targets within your organisation and to external stakeholders (suppliers, final consumers, community groups etc.).

Criteria 2:

Design & Procurement:

This criteria considers actions taken to ensure that sustainability principles are considered in the design or

procurement of both new and existing packaging through use of the Sustainable Packaging Guidelines (SPGs).

- Use the Sustainable Packaging Guidelines to review our packaging to identify opportunities for improvement.
- Record the outcomes of reviews or packaging using the Sustainable Packaging Guidelines so that any team member can refer back to them in future and for auditing purposes.
- Conduct packaging reviews using the SPGs for **20%** of our packaging.

Criteria 3:

Recycled Content:

This criteria considers actions taken to increase or optimise the amount of recycled material used by your organisation.

- Develop a policy or procedure to buy products and/or packaging made from recycled materials.
- Aim to use recycled materials in any packaging where this is feasible, including:
 - Tertiary packaging

Criteria 4:

Recoverability:

This criteria considers actions taken to improve the recovery of packaging at end-of-life and increase use of reusable packaging.

- Investigate whether all of our packaging is recyclable at end-of-life and identify any gaps and opportunities for greater reuse or recycling.

Criteria 5:

Disposal Labelling:

This criteria considers the extent to which packaging has been labelled to help consumers determine what to do with packaging at end-of-life.

No commitments have been made for this criteria this year.

Criteria 6:

On-site Waste:

This criteria considers progress in increasing the amount of on-site solid waste being diverted from landfill.

- Develop a system to collect and recycle used packaging generated at our facilities.

Criteria 7:

Problematic Materials:

This criteria considers the extent to which organisations are actively phasing out problematic and unnecessary single-use plastic packaging and preventing/reducing litter.

- Undertake the following to help reduce the impact of litter:
 - Conduct regular clean-ups on-site
 - Plan to participate in Business Clean-Up Day
 - Some of the activities implemented by RPAC and its four (4) major manufacturers include the following:
 - a) regular clean-ups on-site
 - b) participate on business clean-up day.
 - c) RPAC and one manufacturer has use separate waste disposal
 - d) get rid of Enviro Fill and currently using the recyclable paper instead.
 - e) regular janitorial duties and recycle cardboard

Further commitments:

These commitments look at additional actions the organisation may take to improve reporting.
